Khazanah Graduate Trainee Programmes (KGTPs)

At Khazanah Nasional Berhad (Khazanah), we aim to develop the nation's next generation of leaders through our KGTPs. Trainees will be challenged in a dynamic, competitive and fast-paced environment and be exposed to various sectors and areas, promising you a career that is as challenging as it is rewarding.

Graduate Trainee Programme – Investments (GTP-I)

GTP-I is a 12-month programme aimed at developing well-rounded professionals specialising in investments.

The Programme accepts fresh graduates from any discipline including the following:

- Business, Management, Accounting and Finance
- Statistics, Mathematics and Actuarial Science
- Engineering (all majors in the Engineering field)
- Computer Science

Graduate Trainee Programme — Strategic Management (GTP-S)

The GTP-S is a 12-month programme tailored to develop versatile individuals in strategic and portfolio management.

At the end of the programme, you will be exposed to big picture decision-making and a deeper understanding of the functions of a complex organisation and Khazanah's growing portfolio of investments.

The Programme accepts fresh graduates from any discipline with a passion for problem-solving, proficiency in handling numbers and a desire to work with multiple stakeholders.

Graduate Trainee Programme — Economist (GTP-E)

GTP-E seeks develop economists to research on pertinent macroeconomic and economic development issues.

Successful participants will be funded to complete their PhD studies. Thus, the total duration of the programme is 7 years (including 4 years of PhD studies)

The programme accepts candidates with qualification in Economics, Statistics, Political Science, Mathematics and Actuarial with maximum 2 years relevant working experience; Master Degree is preferred.

At the end of the programme, the GTP-E participants will be exposed to both macroeconomic and development economics research projects and be part of Khazanah Research and Investment Strategy; providing the highest quality thought leadership analysis and advisory on pertinent economic, financial and strategic issues.

Graduate Trainee — **Certified Accountant (GT-CA)**

GT-CA is a 3-year programme (minimum) aimed at developing a cadre of highly trained and experienced individuals who will be qualified accountants.

The Programme accepts fresh graduates from Accounting, Finance and Commerce degree/disciplines.
